

CRIMINALIZATION IS THE FOUNDATION OF THE DRUG WAR, WITH VAST INVESTMENTS IN PUNISHMENT AND SCANT SUPPORT FOR SERVICES. AS A RESULT, DRUG POSSESSION IS THE MOST ARRESTED OFFENSE IN THE UNITED STATES WHILE OVERDOSE IS THE LEADING CAUSE OF ACCIDENTAL DEATH.

DPA SEEKS TO EXPAND ACCESS TO HEALTH AND HARM REDUCTION SERVICES, AND TO REDUCE CRIMINAL PENALTIES FOR DRUGS. RECENT ACCOMPLISHMENTS INCLUDE:
